(GC) IS COMMITTED TO STRENGTHENING THE EFFICIENCY AND CAPACITY OF EXISTING ORGANIZATIONS BASED IN GALAPAGOS. GC GRANTS IN THIS AREA INCLUDED HELPING THE GALAPAGOS' BIOSECURITY AGENCY CREATE NEW SYSTEMS AND PROTOCOLS TO DETECT INVASIVE SPECIES AND PREVENT HIGHLY CONTAGIOUS DISEASES IN FARM ANIMALS. FUNDS WERE ALSO USED TO BUILD A TREATMENT CENTER FOR LOCAL CATS AND DOGS TO ENSURE THEIR HEALTH AND SAFETY. WE ALSO PROVIDED FUNDING TO CREATE A MODEL FOR SUSTAINABLE/LOW INPUT AGRICULTURE FOR THE ISLANDS, ENCOURAGING REDUCED OR NO USE OF CHEMICALS WHICH HAVE HARMFUL IMPACTS ON NATIVE AND ENDEMIC WILDLIFE.
