GC GRANTS IN THIS AREA INCLUDED HELPING THE GALAPAGOS' BIOSECURITY AGENCY CREATE NEW SYSTEMS AND PROTOCOLS TO DETECT INVASIVE SPECIES AND PREVENT HIGHLY CONTAGIOUS DISEASES IN FARM ANIMALS. FUNDS WERE ALSO USED TO BUILD A TREATMENT CENTER FOR LOCAL CATS AND DOGS TO ENSURE THEIR HEALTH AND SAFETY.
